**II. Approval of minutes of the previous ELAC meeting** Roger Espinosa approved the motion and Andrew Franco seconded the motion.

## **III. LCAP Presentation & CSI Updates - Funding, Goals, and Actions**

Andrea Ayala went over and elaborated on the following updates and plans:

- Graduation Rate Focus: The school continues to address its graduation rate through the CSI Plan.
- Differentiated Assistance: Embedded in LCAP Goal 1.2, CVW is collaborating with the County Office of Education, providing interventions for targeted student groups.
- SMART Goals: CVW has developed SMART Goals for the required actions in the LCAP, with evidence of implementation to be shared with educational partners and the school board through PAC/ELAC meetings, the Mid-Year Monitoring Report, and the LCAP Goal Analysis.
- LCAP Infographic was shared with the participants in which Ms Ayala highlighted the School Profile, LCAP Budget, Graduation Highlights, and LCAP Goals.

Participants provided a “thumb-up” consensus to acknowledge the goals, actions, and budget expenditures.

## **IV. SARC (School Accountability Report Card)**

- Ms. Ayala informed the community members, parents/guardians, and participants when the SARC will be approved, and when and where it will be posted on the school website. Ms. Ayala elaborated on what information the SARC contains. Educational partners were appreciative, and gave a consensus by nodding and gave a “thumbs-up” when they heard of the information regarding the SARC.

## **V. 23-24 Title I Program Evaluation**

- Ms. Ayala went over Title 1 funds, Title 1 program eligibility and reported out the findings on the LCAP Goals. Ms. Ayala elaborated on what steps CVW will be taking in the future to continue to work on these goals. Educational partners gave a consensus approval with a “thumbs-up”.

## **VI. 24-25 Title I Annual Meeting**

- Ms. Ayala discussed that the focus of the Title I program is Literacy. Ms. Ayala informed educational partners of the Title I funding that the school will be receiving this year and how these funds will be used to support additional staff and homeless students and increase Parent Engagement. Upon asking what might be some other academic supports the school can provide for struggling students, the community members/parents/guardians expressed that they would like the school to provide/increase the following:
  - Transportation support for students who live in remote communities. Some suggested to start a carpooling service.
  - More tutoring support with Spanish-speaking tutors.
  - Packets to be translated into Spanish. Specifically, math packets should be translated adequately so that the equations and math symbols still make sense.

Ms. Ayala also reminded them to make sure that their voice is heard by filling out the LCAP Parent and Student Survey at the end of the presentation.

#### **VII. California Community Schools Partnership Program (CCSPP) Grant Updates**

- Ms. Ayala went over the CCSPP Planning Grant, comments were made on approving the allocation of resources.

#### **IX. Important Upcoming Events**

- Ms. Ayala informed parents of the upcoming Thanksgiving Holiday Dinner Plates that will be handed out to students the week before Thanksgiving. She informed participants of the Thanksgiving Break and Winter Break dates.
